**NOTIFICATION**

**Whereas**, the Central Government is empowered under Section 3 of the University Grants Commission (UGC) Act, 1956 to declare, on the advice of the UGC, an Institution of higher learning as deemed to be University.


2. **And whereas**, in exercise of the powers conferred by Section 3 of the UGC Act, 1956, the Central Government vide its Notification No.9-16/2007-U3(A) dated 03.07.2008, on the advice of UGC, had declared Indian Institute of Space Science and Technology (IISST), Thiruvananthapuram, Kerala as an Institution deemed to be University under de-novo category, for a **provisional period of five years**. This declaration was subject to the condition that the status conferred upon the IISST will be confirmed after five years on the basis of performance reports of the Expert Review Committee of the UGC and the recommendation of the Commission thereon and the Department of Space shall finalize the Memorandum of Association (MoA) and Rules of the IISST in accordance with the model MoA/Rules prescribed by the UGC and in concurrence with the Commission.

3. **And whereas**, the functioning of Indian Institute of Space Science and Technology (IISST), Thiruvananthapuram, Kerala was reviewed by the UGC with the help of its Expert Committee during 29-31<sup>st</sup> January, 2018. The report of the Expert Committee was placed before the Commission in its 530<sup>th</sup> meeting (Item No.2.12) held on 20.03.2018. The Commission considered the report and the following resolution was forwarded to this Ministry:

"Considered and approved with the condition that the suggestions by the visiting Expert Committee, if any, will be addressed within a period of six months and the compliance report would be submitted alongwith documentary proof to UGC."

4. **Now, therefore**, in exercise of the powers conferred under Section 3 of the UGC Act, 1956, the Central Government, on the advice of the UGC, do hereby extend / regularize the deemed to be University status to Indian Institute of Space Science and Technology (IISST), Thiruvananthapuram, Kerala from 03.07.2013 onwards with the condition that the Institute shall submit compliance report in respect of the suggestions given by the UGC Expert Committee.



### अधिसूचना


जबकि, केन्द्र सरकार को विश्वविद्यालय अनुदान आयोग (यूजीसी) अधिनियम, 1956 की धारा 3 के तहत, यूजीसी की सलाह पर, किसी उच्चतर अधिगम संस्था को सम-विश्वविद्यालय के रूप में घोषित करने की शक्ति प्राप्त है।

2. और जबकि, केन्द्र सरकार ने यूजीसी अधिनियम, 1956 की धारा 3 द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए, अपनी दिनांक 03.07.2008 की अधिसूचना सं 9-16/2007-यू.3 (ए) के जरिए यूजीसी की सलाह पर, भारतीय अंतरिक्ष विज्ञान और प्रौद्योगिकी संस्थान (आईआईएसएसटी), तिरुवनंतपुरम, केरल को पांच वर्षों की अनंतिम अवधि के लिए नई श्रेणी के तहत समविश्वविद्यालय संस्था घोषित किया था। यह घोषणा इसके अध्यक्षीन थी कि आईआईएसएसटी को दिए गए दर्जे की, यूजीसी की विशेषज्ञ समिति की कार्य-निष्पादन रिपोर्ट और तत्संबंधी आयोग की सिफारिश के आधार पर, पांच वर्ष के बाद पुष्टि की जाएगी और अंतरिक्ष विभाग, यूजीसी द्वारा विनिर्धारित मॉडल संगम जापन/नियमावली के अनुसार और आयोग की सहमति से आईआईएसएसटी के संगम जापन (एमओए) और नियमावली को अंतिम रूप देगा।

3. और जबकि, यूजीसी द्वारा अपनी विशेषज्ञ समिति की मदद से 29-31 जनवरी, 2018 के दौरान 'भारतीय अंतरिक्ष विज्ञान और प्रौद्योगिकी संस्थान (आईआईएसएसटी), तिरुवनंतपुरम, केरल की समीक्षा की गई थी। विशेषज्ञ समिति की रिपोर्ट दिनांक 20.03.2018 को आयोजित इसकी 530वीं बैठक (मद सं. 2.12) में आयोग के समक्ष प्रस्तुत की गई थी। आयोग ने रिपोर्ट पर विचार किया था और इस मंत्रालय को निम्नलिखित संकल्प अयोषित किया गया था:

“विचार किया गया और इसके अध्यक्षीन अनुमोदन किया कि विजिटिंग विशेषज्ञ समिति द्वारा दिए गए सुझावों पर, यदि कोई हों, छह माह की समयावधि के भीतर विचार किया जाएगा और यूजीसी को दस्तावेजी प्रमाण सहित अनुपालन रिपोर्ट प्रस्तुत की जाएगी।”




